2.12 How does IQAC Contribute/Monitor/Evaluate the Teaching & Learning processes :

IQAC regularly meets for the discussion of prospective plans for academic development. It makes suggestions to the Principal / Management about the aimed development in the teaching – learning process. The Academic Calendar is suggested to be prepared well in advance. Evaluation of the teaching – learning process is the ongoing exercise. IQAC also focuses on aspects that contributes to holistic development of students. The committee deliberates on the results of the students appearing for Mid-Semester (conducted by the college) and End-Semester (conducted by the University) to get a fair idea of teaching – learning process so far as it relates to measures to be taken by the college is concerned.

6.3 Quality improvement strategies adopted by the institution for each of the following:

6.3.1 Curriculum Development

As R. J. Tibrewal Commerce College (RJTCC) is affiliated to Gujarat University, there is a little scope left for curriculum development on our own. However, many of the faculty members of the college have got membership at the Board of Studies – a body working for preparing syllabus. They positively influence in the field of the development of curriculum, preparation of course content and study material for the subjects of Soft Skills and Foundation Courses for each of six semesters. The College management motivates its staff members and provides all the necessary facilities and permissions required for participation in exercise related to curriculum development. Faculty members are also involved in framing syllabus for schools of Gujarat Secondary and Higher Secondary Education Board.

6.3.2 Teaching and Learning

Teachers are motivated and instructed to adopt teaching methods that suit need of the subject. Faculty members are preparing teaching plan in advance to ensure coverage of entire curriculum. Information regarding seminars, workshops are disseminated amongst students from time to time. Students are also encouraged to make presentations in class as also at various seminars. Multimedia and audio visual devices are used for the project work, group discussion and field work.

6.3.3 Examination and Evaluation

An examination committee is formed to conduct internal examinations. A preplanned schedule is provided to the students well in advance for mid semester examination and is conducted in two sets pattern. Transparent policy regarding calculation of internal marks is in place. University examinations and evaluation have been conducted regularly and the faculties of the college have significant contribution for conducting university examinations and in evaluating answer sheets.

The college encourages and provides all required assistance to its teachers and students to participate in all research related activities as also for professional development.

6.3.5 Library, ICT and physical infrastructure / instrumentation

Sufficient number of computer system is provided in administrative area, staff room. Computer Laboratory has LAN system and broadband internet facility is provided in all systems. Open access systems are provided to the students in the library and e-book bank is maintained. A list of new arrivals is displayed on notice board of library.

The teaching staff members has shown upward mobility in enhancing their academic profile by authoring book, contributing to research papers, articles in news-papers/magazines, and also by perusing Ph.D., and many professional courses. 7. Innovations and Best Practices

7.1 Innovations introduced during this academic year which have created a positive impact on the functioning of the institution. Give details.

RJTCC has made innovation in form of introducing ideas, practices in order to add and improve the standard of education in general and inculcate values of social service. NSS unit of RJTCC became active right from its inception.

Shri B D Raval, program officer, NSS, RJTCC attended an orientation seminar at Mount Abu between 29th and 31st August 2014 and attained guidance regarding the functioning of NSS unit in college.

In the month of September 2014, college NSS unit conducted various activities regarding cleanliness. Between 25th September and 2nd October as part of *Swachcha Bharat Saptah*, 66 volunteers spread awareness regarding cleanliness area.

26 volunteers visited V. S. Hospital and educated patients about the idea of maintaining cleanliness to avoid sickness and can be free from the resultant loss of income and physical health.

In the month of November, volunteers of NSS took up the issue of 'Traffic Awareness' They took an oath to follow traffic rules in presence of the police Commissioner and contributed their help to the traffic police.

Program officer Shri B D Raval participated in a Training Workshop organized at Gujarat Vidyapeeth between 15th and 19th December, 2014.

A week long camp was organized at Khodiyarpura, a small village of Matar Taluka, Kheda District, between 28th January and 3rd February 2015. 38 volunteers along with program officers Shri B D Raval, Dr. C J Trivedi and Prof. D B Rana stayed there for a week and organized various programs including the issues of cleanliness, importance of education, freedom from addiction etc. By conducting a survey of 313 families of the village, they collected information on which they can work upon in future.

Introduction of NSS activities created social accountability among students.

7.2 Provide the Action Taken Report (ATR) based on the plan of action decided upon at the beginning of the year

On the basis of suggestions/ action decided upon at the beginning of the academic year 2014-15, the following remains the outcome by the end of the April 2015.

1) To activate NSS unit at the college was decided upon.

*Not only did the NSS unit of RJTCC come into being, it immediate by picked up momentum in the right direction as suggested in 7.1.

2) To train and provide recruitment oriented opportunities to undergraduate students of commerce faculty

*Faculty members of RJTCC Dr. N V Suchak, Dr. U S Javeri and Prof. V S Shah motivated students to participate in Finance and Management related Competitions at university and National level Students participated and excelled in competitions like shaping young minds program organized by All India Management Association, MONETA-2014 organized by R A Podar college Mumbai PRAYAG 2015 organized by St. Xavier's college Ahmedabad and CONCURSE 2015 organized by B K Majmudar Institute of Business Administration, Ahmedabad.

*An Industrial/educational visit to Chiripal group of Industries and shanti Business school Ahmedabad was organized and a group of 75 students were enlightened about the actual management and working of textile industry.

- 3) To concentrate and arrange for recruitment drive in the college premises for commerce undergraduate students.
- a) Initial selection process was conducted at college premises by Acme international Ltd in the month of July 2014. Six girls from college completed several stage and were recruited a part time/full time sales girls for Welspun Retail stores in Ahmedabad
- b) An online recruitment test was conducted by L & T construction in the month of December 2014. Many of our post graduate students took test and went ahead with the graduate Commercial trainee (GCT).
- c) After conducting an industry Awareness session in the first week of December 2014, Tata Consultancy Services –TCS progressed with the recruitment procedure and at the end selected 3 post graduate and 6 last year undergraduate student of our college.
- 4) To obtain independent NCC unit for college

As per the government directive, a college has to have facilities of playground for several sporting events in order to avail NCC unit. It is obvious that RJTCC does not qualify itself so far as this requirement is concerned, even then if the government reconsiders for minimetro city like Ahmedabad, there are 32 colleges that have applied and are waiting for a green signal. RJTCC is at the 33rd rank.

- 5) To develop cells for conducting sports and performing Arts related activities at College Campus.
- Sports Activity cell does exist in the college and is performing with flying colors though the snag of having a ground along with the premises is difficult to overcome. Our Director of Physical Education manages very well by providing practice for out-door sports activities at the nearby Gujarat university campus. As a result –
- a) College boys volley ball team has been champion for last 2 years at university level 2013-14, 2014-15 and many of our students have been selected for zonal level teams
- b) College girls' volleyball team became runner up at district level in 2013-14 and one of our student has been selected for zonal level team.
- c) College cricket team became champion and got Red Bull champion's Trophy in 2014. Two players have been an active part of Gujarat Ranji team. One played Invitation Cup Tournament at Bangaluru in January 2014. Also one got selected in India under-23 probables
- d) College football team was semifinalist in football inter-college tournament 2014-2015 and four students got selected for a zone team
- e) Five students got medals at Ahmedabad zone Athletic Meet during 2014-15.

For performing arts related activities, the college has spared one room as activity two but do not have proper auditorium still the college manages to attain top position in performing Arts related activities and intellectual activities.

- a) At events like 'MONETA', 'Synergy', 'Carbon Credit', 'Battle of Nations' and 'Bell Weather', college students got medals and cash prize. In 'battle of National' RJTCC secured 4th rank among 60 colleges participated from all over India.
- b) JOSH is a dance competition among the college of Ahmedabad RJTCC won in the event called 'Bollywood Dhamaka' and became second Runner up in 'Theme choreography'
- c) College students topped in fine Arts activities at Gujarat university Youth Festival event at zonal level.

- I. At RJTCC internal examinations have been conducted with question papers in two sets. Two-set Test has been a tradition since 1995-96. It is a matter of pride that we have been able to continue the practice and that too with great success.
- II. Advancement and updating knowledge by Faculty members has always been a top priority at RJTCC During 2014-15 Prof. Surabhi Pillai has been granted duty leaves for pursuing her Ph.D. program as part of XIIth plan of UGC research paper writing, their presentation using multimedia techniques at state and nation as well as international level conferences / seminars and their publication in journals/ book have been a regular practice among faculty member of RJTCC.

7.4 Contribution to environmental awareness / protection

As an official practice and formal tradition, though environmental audit is not conducted at RJTCC we take proper care for the conservation of environment. a) Not only on the occasions of our national festival but also very frequently has the college organized tree plantation programs. The college spends sizable amount for nurturing and conserving vegetable inside and outside college campus. The college cells of NSS and CWDC also conduct tree plantation programs b) An inherent discipline is inculcated among students for being economical about the use of electricity. They believe in not spoiling benches, walls, staircases and lecture halls of college premises. They make it a point not to disturb residential premises beside the college by not honking. c) The well planned architecture of the college helps having proper light and aeration in lecture halls. As a result electricity is sparingly used. Even computers are meticulously switched off after use. d) Water is judiciously used strictly avoiding its waste and resulting dirt and hazard for hygiene. e) In order to maximize efforts in the college avoids burning of wastage like papers or dry leaves. As a result the environmental pollution is prevented from the resultant smoke. f) Electrical and electronic gadgets are services at regular intervals and are discarded after maximum 4/5 years of use.

7.6 Any other relevant information the institution wishes to add. (for example SWOT Analysis)

In order to analyze our strength, weaknesses, opportunities and Threats (SWOT), an online investigation was conducted through a questionnaire distributed among students of RJTCC Question regarding college infrastructure management practices, Administrative policies and strength and weakness of teaching faculty member were included. A team comprising of three faculty members and two non-teaching staff members worked hard on the project. Certain noteworthy findings are as follows:

- a) There should be separate washrooms for boys and girls on each floor
- b) There should be a Ladies Room for female students of the college.
- c) There should be an auditorium for events of gatherings.
- d) The minimum attendance requirement in each semester should be brought to 60% from 75%
- e) The administrative staff should be properly trained and made more computer savvy.
- f) The non-teaching staff; especially imparting duties on interaction counters should be more polite and able to interact properly in languages other than Gujarati.
- g) According to the data collected, the teaching staff members are well-equipped and keep themselves updated. The students only want their teachers to be morefriendly; though they accept that they have always been motivating and supportive.
